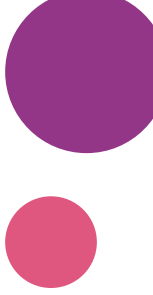


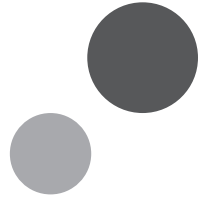

Partners in Planning (PIP)

The Federation is committed to providing planning information and education to communities to facilitate public participation in the planning process. The Partners in Planning Program (PIP) is an award-winning certificate program offered by the Federation of Calgary Communities in partnership with The City of Calgary. The program is geared towards helping community association planning volunteers and the public to develop skills for effective participation in the planning process. Participants who complete all program requirements receive a PIP completion certificate, which is signed by the Mayor, the President of the Federation, and the General Manager of Planning & Development. The next PIP course will be offered in January 2020.

Each Course:

- PIP courses are offered on Saturday mornings
- You must register online at calgarycommunities.com
- There is always time for questions and networking

How it Works:

- A certificate is earned by completing four courses (three core and one elective)
- You may take any course as much as you like
- This is an ongoing program so there is no time limit to complete the requirements
- There are no pre-requisites and you may start with any course

PIP: Understanding Planning & Design (Core Course)

Discover how policies that guide development in Calgary are created and applied. In this course learn more about these foundational documents such as the Municipal Development Plan (MDP), the Guidebook for Great Communities (formerly Developed Areas Guidebook) and local area plans. Discover how these policies and others are applied to applications as they move through the approvals process.
