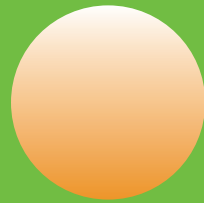
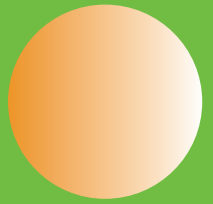

## PARTNERS IN PLANNING

The Federation is committed to providing planning information and education to communities to facilitate public participation in the planning process. The Partners in Planning Program (PIP) is a free, award-winning certificate program offered by the Federation of Calgary Communities in partnership with The City of Calgary. The program is geared towards helping community association planning volunteers and the public to develop skills for effective participation in the planning process. Participants who complete all program requirements receive a PIP completion certificate, which is signed by the Mayor, the President of the Federation and the General Manager of the City of Calgary Planning & Development.

**If you were unable to complete your PIP Certificate last year due to COVID-19, you can take any courses you missed this year to count towards your certification.**

**Please note: We are working with The City to set dates. We will update as those are finalized.**

### Heritage (Elective Course)

Heritage buildings are valuable assets to cities.
